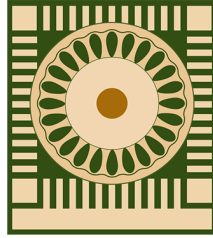

BACKGROUND

The City of Hayward currently utilizes an at-large election system for the Mayor and City Council members. This means that the voters from the entire City choose the Mayor and six (6) City Council members. A district-based election system is one in which the city is geographically divided into separate districts, each with one Council member who resides in the district and is chosen by the voters residing in that particular district.

On March 10, 2024, the City received a letter from attorney Scott Rafferty, which asserted that the City's at-large method of election could be in violation of the California Voting Rights Act (the "CVRA"). The CVRA allows a city to declare its intent to change to district-based elections and gives it 90 days within which to adopt districts. At the time it adopted its resolution of intent, the City's deadline for adoption of districts was July 15, 2024. However, state law also allows the parties to a CVRA complaint to extend the deadline by another 90 days, and on May 15, 2024, the parties agreed that the City would have until October 14, 2024 to adopt districts for use in the 2026 elections.

DISCUSSION

Public Hearing Timeline

Pursuant to Elections Code section 10010, the City was required to hold at least four public hearings in connection with the establishment of electoral districts. More specifically, the City was required to hold at least two public hearings over a period of no more than 30 days before any draft map(s) of proposed voting district boundaries were drawn. After all draft maps were drawn, the City was then required to publish at least one draft map and to hold two additional public hearings over a period of no more than 45 days, so the public could provide input on the content of the draft map(s) and proposed sequencing of elections.

The first two public hearings to receive input regarding composition of the proposed districts occurred on May 14, 2024 and May 28, 2024 respectively. A third public hearing was held on August 13, 2024, during which Council received additional community input and provided initial direction to the demographer regarding the preparation of draft district maps.

Three draft district maps were posted to the City's districting website on August 27, 2024, as required by state law. Copies of the staff reports, as well as video and audio recordings of these hearings, and links to the three draft maps are available for the public through the following link: [Schedule | City of Hayward Districting Project \(maphayward.org\)](https://maphayward.org)

At the fourth public hearing, held on September 3, 2024, the City Council received input from the community regarding the three draft district maps prepared by the demographer. Additionally, the demographer provided a PowerPoint presentation which is currently

available on the City's website and discussed the three draft district maps with Council. Following the presentation and discussion about the draft maps, the Council moved to advance draft Map 1, with modifications. The finalist map was published on the City's website on September 6, 2024 and can be viewed at [Draft Maps | City of Hayward Districting Project \(maphayward.org\)](https://www.cityofhayward.org/DocumentCenter/View/10444/Draft-Maps-City-of-Hayward-Districting-Project).

During this fifth hearing, the Council will, a) formally select the final map establishing the boundaries of six (6) voting districts; b) provide final direction on the sequencing of elections to create staggered terms of office; and, c) introduce an ordinance that will transition the City's election system from an at-large system to the district-based system beginning in 2026.

A final public hearing adopting the ordinance is tentatively scheduled for October 8, 2024, meeting the October 14, 2024 deadline to transition to district-based elections.

Districting Criteria

In creating the boundaries of the six districts, the process must comply with state and federally mandated criteria requiring each district to be as nearly equal in population as practicable and drawn in a manner that complies with the 14th Amendment, the State and Federal Voting Rights Act, and the criteria outlined in Elections Code section 21130.

All draft maps used in this process complied with the basic state and federal districting criteria. Additionally, the drafts maps incorporated public input, including submitted maps and Communities of Interest (COIs) and Neighborhoods. Districting is a process of constraints. Community members submitted dozens of proposed maps and communities of interest, but not all public input and all neighborhoods could be included and maintained in each map because population equality is the first legal criterion to consider. These draft maps laid out the districts in different ways to show how input could be accommodated. They could be modified within constraints established by law, based on input received during the public hearing.

Sequencing of Elections

The Mayor and members of the City Council currently serve staggered terms of office. The terms of Mayor Salinas, and Council Members Roche and Syrop expire in November 2026. The terms of Council Members Bonilla, Jr., Andrews, Zermeno, and Goldstein expire in November 2024. The Elections Code allows district elections to be sequenced to create staggered terms of office. In determining the sequence of elections, the City Council is required by state law to consider the purposes of the CVRA and to take into account the preferences expressed by members of the districts.

The first election under the new districts will be in November, 2026. Because state law prohibits cutting short the term of any member and because only two members' terms will expire in 2026, there will be elections held in two of the new districts in 2026 and four districts in 2028. As noted above, the CVRA provides that in deciding the sequence of

elections under the new districts, the Council shall give special consideration to the purposes of the CVRA and “shall take into account the preferences expressed by members of the districts.”

The purpose of the CVRA is to prohibit use of an at-large method of election that impairs the ability of a protected class to elect candidates of its choice or to influence the outcome of an election. Because the CVRA challenge against the City was brought on behalf of Asian American voters, Council could consider whether the purposes of the CVRA would be best met by allowing districts with large numbers of Asian American voters to have an election in 2026 or in 2028. Because turnout is often higher in presidential election years, an argument can be made for scheduling districts with higher numbers of the protected class in those years. There is also an argument, however, that it is better for such districts to be up at the first available election to avoid any further claims of vote dilution. The Council should seek public input on this issue before deciding on the sequencing for the first elections under the new plan. After receiving public comment on these issues and after consideration of the factors to be taken into consideration, staff will be in a position to advise on the districts to be prioritized in sequencing for 2026 and 2028.

Ordinance

The attached ordinance (Attachment II) would amend the Municipal Code by adding Article 16 to Chapter 2. The ordinance would establish six (6) City Council districts for the City of Hayward, as described in the final district map selected by the Council and establish the sequence in which the respective districts would be up for election, commencing in 2026. The specific election sequence will be incorporated into the ordinance based on the Council’s direction as part of the introduction process.

Community Outreach

The City conducted community outreach under the facilitation of City staff and consultant Tripepi Smith. The City established a website in May of 2024 ([Welcome | City of Hayward Districting Project \(maphayward.org\)](https://www.hayward-ca.gov/welcome-city-of-hayward-districting-project-maphayward.org)) to facilitate sharing information and gathering input on the drawing of district-election maps. The website shows the district maps and communities of interest maps that were submitted by community members over the past few months. The draft district maps prepared by the demographers are also posted to the website. Moreover, the final map selected by the City Council, with modifications, is posted to the website.

Community members can ask questions and provide input about the maps by calling (510) 583-4444 or by sending an email to districting@hayward-ca.gov.

Since the draft district maps were posted on the website, Tripepi Smith worked with City staff to call over 100 targeted community stakeholders to notify them of the opportunity to comment on the maps and to attend the September 3 Public Hearing. Additionally, the City has sent emails to the 62,573 subscribers of the City’s e-newsletter with information about the

draft maps and the public hearings in September and October. In addition to the public hearings, the City held a virtual workshop on June 11, 2024 and an in-person workshop on July 9, 2024 at Chabot College where interested community members could learn about the districting process. The City continued its outreach efforts as we moved toward Public Hearing No. 5.

Please note that Spanish, Mandarin, Vietnamese and Tagalog interpreters continue to be available at all public hearings upon request.

FISCAL IMPACT

Significant staff resources will be devoted to carrying out the process described in this report, including public outreach strategies. The City will also incur costs related to the engagement of outside legal counsel, the demographers and other consultants that may be necessary.

ORDINANCE NO. 24-_____

AN ORDINANCE OF THE CITY COUNCIL OF THE CITY OF HAYWARD ADDING ARTICLE 16 TO CHAPTER 2 OF THE HAYWARD MUNICIPAL CODE, ESTABLISHING DISTRICT-BASED CITY COUNCIL ELECTIONS; AND FINDING THAT THE ACTION IS EXEMPT FROM CEQA REVIEW

WHEREAS, the City of Hayward currently elects its Mayor and City Councilmembers using an at-large election system; and

WHEREAS, in the at-large election system, candidates may live in any part of the City and the Mayor and each Councilmember is elected by the voters of the entire City; and

WHEREAS, in a by-district election system, a candidate for City Council must live in the district which he or she wishes to represent, and only the voters of that district are entitled to vote to decide who their representative will be; and

WHEREAS, the purpose of this Ordinance is to enact, pursuant to California Government Code Section 34886, an ordinance providing for the election of the members of the City Council of the City of Hayward by district in six (6) single-member districts; and

WHEREAS, adoption of this Ordinance is exempt from environmental review as the adoption of this Ordinance does not qualify as a “project” pursuant to the California Environmental Quality Act (“CEQA”), under Public Resource Code Section 21065 and CEQA Guidelines Section 15320, 15378, and 15061(b) (3) as there is no possibility that such action would cause either a direct, or reasonably foreseeable indirect, physical change in the environment; and

WHEREAS, the accompanying October 1, 2024 City Council staff report and attachments and exhibits thereto are hereby incorporated by reference as though fully set forth herein.

NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF HAYWARD DOES ORDAIN AS FOLLOWS:

Section 1. Article 16 is added to Chapter 2 of the Hayward Municipal Code to read in full as follows:

ARTICLE 16
BY-DISTRICT CITY COUNCIL ELECTIONS

SECTION 2-16.00 – Purpose. The City Council hereby declares that the change of method of electing members of this Council hereby enacted is being made in furtherance of the California Voting Rights Act of 2001.

SECTION 2-16.10 – Establishment of City Council Districts.

- (a) Six (6) City Council districts are hereby established in the City of Hayward. The boundaries and identifying number of each district shall be as described on the City Council District Map located at [hyperlink to map to be inserted here] and incorporated herein. To the extent there is a conflict between the descriptions contained in the Ordinance codified in this Article and the map incorporated herein, the map shall prevail.
- (b) If necessary to facilitate the implementation of this Ordinance, the City Manager or his or her designee is authorized to make technical adjustments to the district boundaries that do not substantively affect the populations in the districts or the eligibility of candidates. The City Manager shall consult with the City Attorney concerning any technical adjustments deemed necessary and shall advise the City Council of any such adjustments required in the implementation of the districts.
- (c) Elections shall take place, and Councilmembers shall be elected, “by-districts” as that term is defined in California Government Code Section 34871, meaning one member of the City Council shall be elected from each district, by the voters of that district alone.
- (d) The districts specified in subdivision (a) shall continue in effect until they are amended or repealed in accordance with law.

SECTION 2-16.20 – By-District Electoral System.

- (a) Pursuant to California Government Code Sections 34886 and 34871(c), Councilmembers shall be elected by-districts in six (6) single-member districts.
- (b) Except as provided in subdivision (c) hereof, the Councilmember elected to represent a district must live in that district and be a registered voter in that district, and any candidate for City Council must live in, and be a registered voter in the district in which he or she seeks election at the time nomination papers are issued, pursuant to California Government Code Section 34882 and Elections Code Section 10227.
- (c) A Councilmember in office at the time this Article takes effect shall continue in office until the expiration of the full term to which he or she was elected or appointed and until his or her successor is qualified.

ATTACHMENT II

- (d) Upon expiration of the full term of each Councilmember elected at-large, that Councilmember's successor shall be elected on a by-district basis in the districts established in Section 2-16.10 and as provided in Section 2-16.30. A vacancy in a Councilmember office elected by-district shall be filled according to law by a person qualified to hold the office, who lives in the district.
- (e) The terms of office of each Councilmember elected to the City Council pursuant to this Ordinance shall remain four (4) years as specified in the City Charter.
- (f) The method of electing the office of the Mayor at-large shall not be affected by the provisions of this Ordinance.

SECTION 2-16.30 – Sequence of District Elections.

- (a) Councilmembers from Districts ___ and ___ shall be elected beginning at the General Municipal Election in November 2026, and every four years thereafter.
- (b) Councilmembers from Districts ___, ___ and ___ shall be elected beginning at the General Municipal Election in November 2028, and every four years thereafter.

Section 2. California Environmental Quality Act. Adoption of this Ordinance is exempt from environmental review as the adoption of this Ordinance does not qualify as a "project" pursuant to the California Environmental Quality Act ("CEQA"), under Public Resource Code Section 21065 and CEQA Guidelines Section 15320, 15378, and 15061(b) (3) as there is no possibility that such action would cause either a direct, or reasonably foreseeable indirect, physical change in the environment.

Section 3. If any section, subsection, paragraph, or sentence of this Ordinance, or any part thereof, is for any reason found to be unconstitutional, invalid, or beyond the authority of the City of Hayward by a court of competent jurisdiction, such decision shall not affect the validity or effectiveness of the remaining portions of this Ordinance.

Section 4. The effective date of this Article shall be thirty (30) days after its adoption by the City Council.

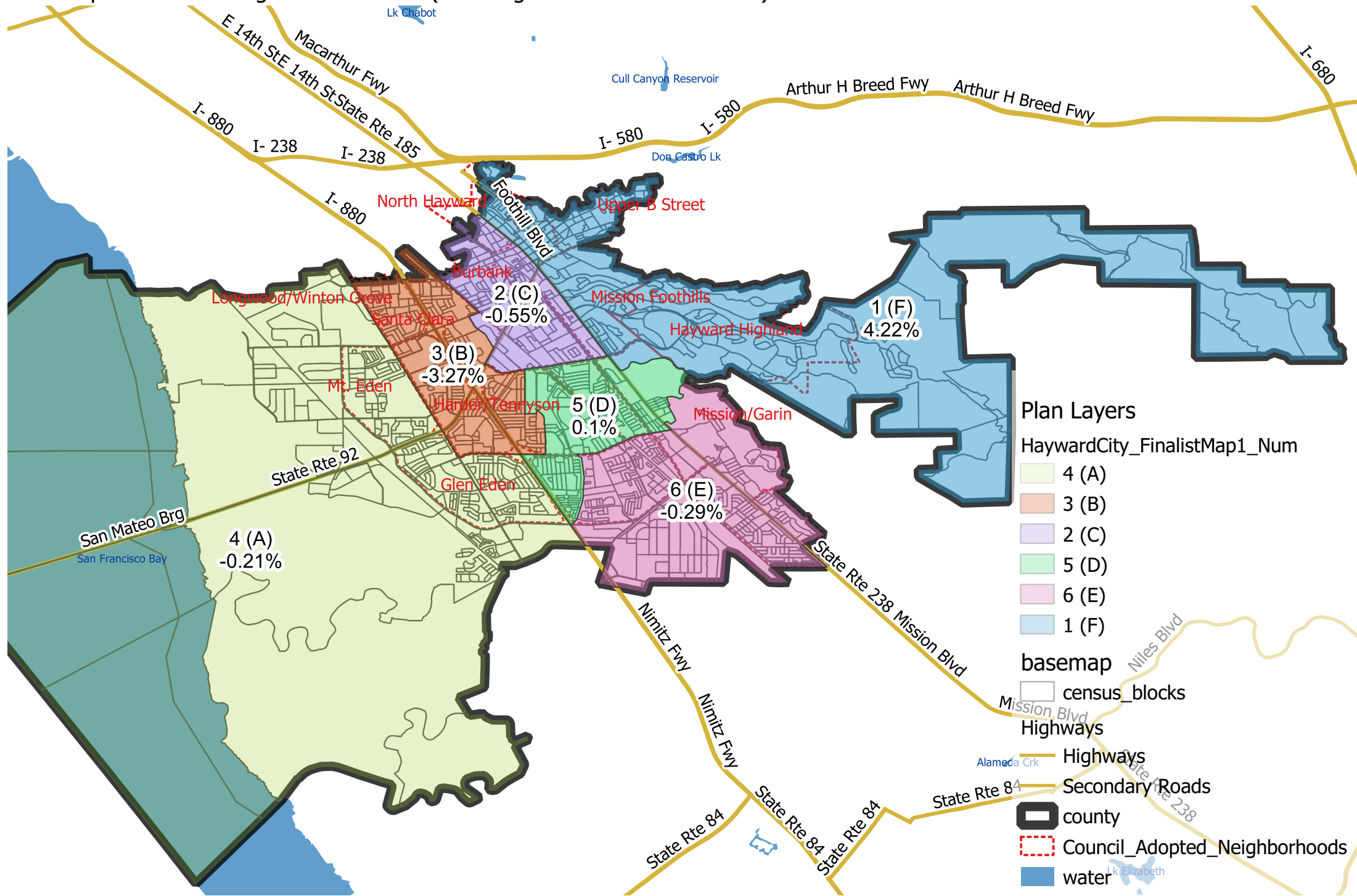
